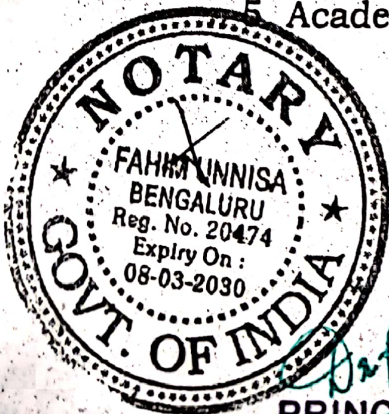

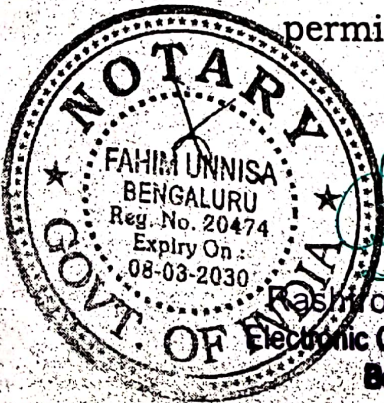

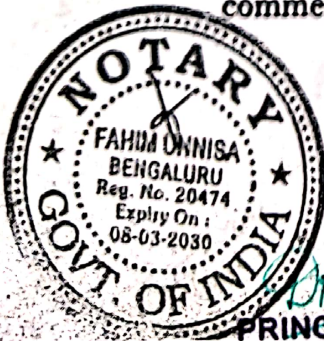

6. This High School is permanently unaided as per Government Notification No.: BD 175 PMC 95 Dated: 07/09/1998 and Dated: 29/12/1998. The Management Board shall issue a letter of consent on a stamped paper of Rs. 50/- certified before a Notary that it does not want any grant from the Government.
7. The Karnataka Private Educational Institutions (Recruitment, Service Conditions and Provisions of Employees of Private Aided Primary and Secondary Educational Institutions) Rules, 1999 shall be strictly followed.
8. Only the text books and examination procedures prescribed by the Department and the Government shall be used in its own system.
9. Only trained and qualified teachers as per the Department rules shall be employed.
10. Medical examination of students should be conducted every year as per rules.
11. The institution should keep the security deposit in the joint account of the District Deputy Director and the Governing Board to start the school.

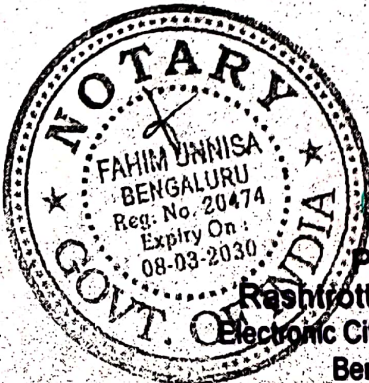

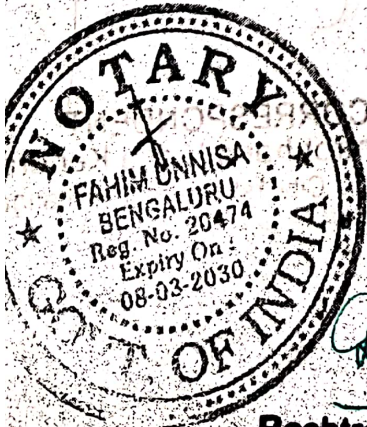

18. Certificate regarding building safety shall be renewed from time to time by the competent authority and submit it to the concerned Deputy Director.
19. If the documents uploaded online are not genuine, this order shall stand cancelled.
20. Service security rules shall be followed compulsorily in the school.
21. The first accreditation shall be granted only after verifying the authenticity of the original documents uploaded in the software such as the land transfer document, building safety certificate and fire safety certificate.
22. The proposal for first accreditation shall be submitted to this office within 03 months. The Deputy Director shall obtain the information of the Education Act and the Government Order dated: 30/09/2007, Appendix 03 and on this basis, it is mandatory to obtain first accreditation within three months of the commencement of the school. If the accreditation is not obtained within the specified period, the registration shall be automatically cancelled.
23. After the school registration process is completed, the entire document/information in the application submitted online by the management board will be made publicly available on the departmental website.

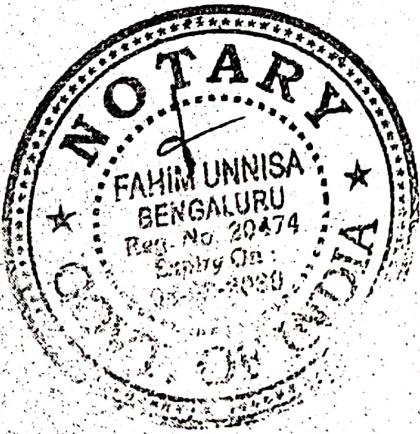
